5. Exercise Watermark: Presentation by Mick Potter, Emergency Planning Officer: following flooding in 2007, report recommended exercise at local community level. Can validate our Emergency Plan and call the Committee together just to see how we think we can respond and look at things we can do. Number of ways the exercise can be run. Thirty councils are participating some are doing a flood fair or a rest centre. There are options available. Would like a firm commitment in the near future of what the Parish Council would like to do. Would work initially with two Parish Councillors and the Clerk. As part of the Exercise Warwick University have some funding for students to come and record what actually happens. National Body can then understand the impact. Will be a hot debrief immediately after the event and a cold debrief four weeks later and can bring along points for discussion.

#### 9. Items for Discussion

Min 238 Cllr Rickhards: Community Speedwatch Partnerships Suggested at Community Forum meeting by Jenny Murray, Stratford Area Team, WCC that there could be a sharing use of the speed laser gun. Suggested that 4 or 5 Parish Councils could purchase a gun and pass it around each Council as there is only one available in Stratford District.

- Several Villages have carried out speed watches and they have proved popular. Drivers have slowed down.
- Police cannot be everywhere. Given training to volunteers.
- A case for 'joining in' on roads where there is excessive speed.
- Maybe a little dangerous for volunteers.
- Majority of speeding is carried out by locals. Speed guns do work.
   Used in Sambourne and Coughton. If serious could approach other Parish Councils.
- Cameras still not working on A448. Perhaps these should be put right first.
- Should look at alternatives instead of speed gun, maybe flashing signs.
- Would work by using volunteers with a rota system.
- Needs to be looked at long term. Volunteers may get fed up. Item for discussion at next meeting.

Min 239 Cllr Rickhards: Youth Club Lighting

Raised at Community Forum Meeting. Lights in Basketball Court are out of commission. Were turned off following a horrendous electricity bill. Steve Smith, WCC is looking into how lights can be activated. Youngsters themselves had made the lights dangerous. Two lights are now situated in school premises so will have to get permission to access school. Already being done by WCC.

Police are against lights as encourages youngsters to congregate in the

# Allotment Association Meeting 30<sup>th</sup> September 2010 Report given by Cllr McCarthy.

Copy to all Councillors.

Following points raised re the Parish Council:

#### Summary:

- 1. The grass needed cutting near the Dunstall allotment entrance. The Association understood the Parish Council would do it. Is this so?
- 2. Hedge cutting at Station Road. The contractor had cut the hedge but cuttings were left on the path. Is it in the contract to collect and remove them?
- 3. Query if allotment member who cuts the Dunstall hedge on the north side can be reimbursed?
- 4. Letter received from one allotment holder re the best kept allotment but most members were not unhappy with the judging.
- 5. A member has received a letter re an unkempt and unworked plot. Members are unhappy that he is doing the least possible. Suggested that the National Association might have a standard letter to send in such cases with very firm wording, dates etc.
- 6. Leek moth infestations were reported. If anyone has such, the leeks should be burnt as soon as possible.
- 7. Spraying rules were discussed, but the Association would leave it to members good judgement.
- 8. The Association will be attending the Christmas Fayre.

In response the Clerk confirmed that the Parish Council will be cutting the grass near to the Dunstall allotment entance. The Contractor has been told to remove the cuttings at Station Road and the member can submit a tender for the hedge cutting work when they are next due.

Concerning members not tending their plots on Station Road, there is already a system in place which works very well on the Dunstall allotments where two warning letters are sent out by the Secretary. If there is no response a final termination letter is then out by the Clerk.

Cllr Bacon: The Memo of Understanding with two amendments will be looked at by the Association and they will report back at a future meeting.

**Clir Bacon** attended forum event to discuss open space, sport and recreation provision in Stratford on Avon District. District Council employed ARUP Consultants to look at facilities. Will report back. Clerk completed questionnaire for Studley Parish Council.
