Roger Poole, WCC negotiating with Highways Agency before the transfer. WCC are not going to object and support the detrunking. Do not know what work if any they are going to do to improve the road. Cllr Mrs Wersocki questioned Roger Poole if the signs will be changed. Highways Agency should be responsible for changing signs to send traffic down A46 which will remain a trunk road. Highways Agency would like to hand over the road at the least cost to themselves. Need to meet with WCC and press them to get as much done as possible before handover.

Clerk to write and invite Roger Poole to Parish Council meeting to discuss what work we would like to see done before detrunking takes place.

Also invite representatives from Mappleborough Green and Coughton.
