County Council Report given by Cllr Mrs McCarthy

Received a number of calls concerning Studley Library. Wrote to Library Networks & Access Manager.

Summary of reply:

- Warwickshire Library Service has been looking at the potential for relocating the delivery of library services from the existing library building to potential space available in Studley Village Hall. The Library Service has been doing detailed work to look at the cost efficiency of the proposal and also the impact upon service provision.
- In October 2008 Warwickshire County Council Cabinet considered a report 'Framework for the Future: Library Service Transformation.' They resolved that a detailed action plan providing the way forward to 'Review the Library Network' would be brought back to Cabinet in May 2009.
- The Review of The Library Network looks at library provision across the County as a whole, services in Studley are part of this overarching review and more detail about when services in Studley will be reviewed will be included in the action plan. The timings for continuing work to look at Library provision in Studley will be dependant upon decisions made by County Council Cabinet members in May 2009.
- Any alteration to the delivery of Library Services to a community would require
 a community consultation exercise to ensure that local people have the
 chance to share their ideas and views about what they would like to see from
 their Library Service.

Budget still being done. Parties still have to agree. Savings required at present unacceptable as too many cuts proposed.

12. Correspondence SDC

- Min 355 Request for precept requirement for 2009/10 to be submitted as soon as possible. The District Council budget for 2009/2010 will not be known until the budget meeting on 23rd February 2009. Provisional Council Tax Base for Studley calculated at £2068.69. The precept will be paid in two equal instalments by 30th April 2009 and 30th September 2009.
- Min 356 Emergency Planning. Following the emergencies dealt with last year in the District, WCC is reviewing the generic template Parish Council Community Emergency Plan. Invitation to Emergency Planning Workshop on 18th February 2009 at Elizabeth House at 7.00pm. Programme to include an update on emergency planning in Warwickshire, a presentation on the new plan and a workshop session. Cllrs Holder, McCarthy and Redman to attend.
- Min 357 Letter received from Lech Kocan that arrangements have been made for the mobile advertisement board on the Birmingham Road to be removed by Wednesday, 7th January 2009. After this date formal proceedings to regularise a breach of the Advertisement Regulations will commence.
- Min 358 Refuse and Recycling. Final service developments get underway in April 2009. Green waste collection will re-start 6th April 2009 the same

An update leaflet and collection calendar will be issued with the Council Tax Bill at the end of March. The Refuse and Recycling Team are willing to come to a Parish Council meeting to talk about the changes. Decided not to accept offer as already had an informative talk a few months ago.

Draft Core Strategy:

- Decide which elements we would like to retain.
- In Market Town Visions the Draft LDF take into consideration Parish Plans and will help meet ambitions.
- Objective housing and employment development.
- Each of the larger rural settlements of which Studley is one different in size, location and character.
- Service provision to be maintained. Loss of shops and businesses should be resisted.
- Options in place for commercial, housing and business development to reduce the use of private cars. Focusing on settlements with public transport.
- No radical change to green belt policy, with extension of green belt in Mappleborough Green.
- Preferred option for housing in Redditch is the Bromsgrove area.

Clerk to write with the following points:

- i) Point of Parish Plan to be recognised in it's entirety.
- ii) Support policies on main rural centres concerning businesses and commerce
- iii) Retail survey, Market Towns support needed for retail stores. Any development should support the needs of the local population.
- iv) Strongly support the greenbelt policy and retention of the green belt area between Redditch, Studley and Mappleborough Green.
- v) Some element for reduction of traffic on A435 corridor, Coughton, Studley and Mappleborough Green.
