Summary:

- Crooks Lane to be micro asphalted around May/June this year.
- Still waiting for the terms of the Fire and Rescue Review to be decided.
- Potholes are first filled on a temporary basis and then a team comes and permanently fills them. As a result of the wet winter, an unusual number of potholes, some of which have been temporarily filled more than once.
- Still waiting to find out if it is possible for WCC to pay Redditch BC for Studley residents to use their tip.
- Partnership and people is obviously working in the case of possible lottery funding for Studley library. Thanks to the response of residents to the library petition, followed by two people speaking at the Area Committee and the possibility of adding a library to the Village Hall, partnership running is a possibility.
- Children & Young People & Families O & S at present discussing Alcohol & Young People. Also member of The Health O&S which has a panel looking at Children's Obesity.
- County Music Department does a lot of work for the County's children. Every child has the opportunity to learn to play an instrument. Feel that this service should not be cut.
- At some stage, a Children's Centre will be built at the Infant School. These Centres bring together children, their parents/Carers, health visitors, social workers and other workers who help parents who are alone. The Infant School had a well-deserved good Ofsted Report.
