Summary:

Stratford Sustainable Transport Project

The estimate for Stratford Parkway scheme has increased to £7.129m. In addition to capital cost there is a revenue cost of £1.737m. Funding from the Dept of Transport, WCC, Centro, SDC(Developer funding). Station will be by the Park and Ride.

Staff Reductions

Continuing – 141 this year from Children and Young People. This will affect services to varying extents.

People 'Directorate'

Will start on November 1st and incorporates Early Intervention, safeguarding, strategic commissioning, social care, learning and achievement and business management.

Schools

Relationship with LEA being reviewed in light of Academies.

Care Costs

Big increases across the board but they are means tested.

White Paper

Agreement by all 3 parties on the response with a few critical points about the 'Choice' principles citing the Southern Cross Care Homes debacle. Shouldn't have 'choice for choice sake'.
