- Council would prefer fence at south of site to be lower
- Council would like to see developer provide some funding towards investigating a reduction from 40mph to 30mph around the site of development
- Developer to provide a Village Gateway

15/01683/FUL Mr David Bush, Chester House, 91-93 Alcester Road, Studley Demolition of existing shops and offices and erection of apartment block to consist of No.6 one bedroom apartments with parking and garden to the rear Proposed Cllr Smith, seconded Cllr Dixon, voting unanimous to Object on the following grounds:-

- Overdevelopment of site, bulk and mass
- Overlooks adjacent properties
- Contra to Housing Needs Survey 2014 no evidence of widespread need for 1 bed units, rather for 2/3 bed family homes (Policy Com 1)
- Lack of amenity space contrary to NPPF
- Does not enhance or respect listed building adjacent to site
- Detrimental to street scene
- Three storey building in streetscene which is predominantly two storey buildings. Height of building adds to impression of solid blocks of brick detracting from enhancing the area as require by Policy CS9 section B para 1,2, & 8
- Design is bland and uninteresting
- Reduction of visibility splay makes access to Manor Road difficult
- Proposed planting will further obstruct visibility
- Parking court cramped and poor design will leave a view of 18 household bins, 6 cars and a blank wall

# 13. District, County Council & Delegate Reports. County Cllr C Rickhards report:-

- Diamond Bus Service No.67 will be calling at hospital again from 1<sup>st</sup> September 2015.
- County Council Ruling Group plan a series of cuts in Housing related support services. An example is the provision of red alarms in accommodation for the elderly. Opposition parties presented some alternatives. Awaiting decision from Cabinet regarding taking proposals to Full Council.
- County libraries running 4 to 11 year old Reading Challenge (includes Studley Library)
- Period for applying for Member Grants has commenced.
- There is to be a Warwickshire Police Citizen's Academy in the autumn.
- County considering the possibility of using a part of the closed Studley Centre for some kind of activity for dementia sufferers.
- Cllr Rickhards to issue monitoring forms to residents on A435 re volume and speed of HGV's
- Vehicle Activated Signs on Alcester Road, The Slough/Bromsgrove Road and Station Road should be installed in next few months. Funding has been provided.

# District Cllr J Kerridge & Cllr N Moon joint report:-

- Redditch/Bromsgrove joint Local Plan currently proposed land behind Alex and along A455 in Mappleborough Green for development has had serious setback. The Inspector asked for a lot of new work to be done including more on the sustainability appraisal.
- Inspector noted other strategic sites around Studley were correctly NOT brought forward for further analysis and has given the Councils an alternative option of going back to drawing board. He also questioned their 5 year housing land supply and required proof they have one.
- An options study is now commissioned by SDC on the Co-op site including land values, potential development options and the legal case for compulsory purchase.
- Stratford's Core Strategy debated in Council. Many changes. Increased housing numbers and locations for new housing but no changes for Green Belt Policy or Studley Policy, housing numbers etc. The revised Core Strategy approved at Council of 20<sup>th</sup> July will shortly go out to consultation. No changed implications for Studley.
- Enforcement Officer to follow up on builders debris in High Street and signage outside HSBC bank. Also Roy's Bikes site being discussed with developer.
