## Min 195 Review of Waiting Restrictions, Studley

Require clarification from WCC concerning parking in Pool Road. As there is no parking allowed along the recreation ground side of the road, and there is restricted parking along the opposite side due to the zig zag yellow lines outside the school the Councillors wish to know if parking would be allowed on these lines outside school hours. If this is the case they would have no objections.

Also concerns raised about parking bays outside the Estate Agents on the High Street which are on a dangerous bend where there has already been a serious head on collision. Would like these removed with no waiting there at any time.

Clerk to write to see if we can get a report of the Traffic Warden Patrols.

Min 113 Cllr Holder: Exercise Watermark

Certain areas are doing the main exercise. WCC would like to get Parish/Town Councils involved. List of various options for activities that Parish Council may wish to undertake during Exercise Watermark.

- Cannot see the point as Studley never floods to that extent.
- Two years ago there were floods around Studley creating difficulties for people getting in and out of the Village.
- Emergency Plan in place but never been tested.

Min 207 Cllr Mrs Wersocki: Henley in Arden & Studley Area Property Review Important that representatives from the Parish Council attend these meetings and if no one available could the Clerk or her Assistant go? Perhaps in future ask for meetings to be held at an alternative time as Parish Councillors cannot always attend due to work commitments. Clerk to write that the comment in the minutes regarding the Sports & Social Club should read that it is a Village Club not a Private Club.

Min 208 Cllr Mrs Wade: Total Place Workshop Project

- Attended the workshop held in the Village Hall together with Cllrs Beaman, Weddell, Mrs Wright and the Clerk.
- Churches were not involved so Cllr Wade invited Ian Olliver from the Baptist Church.
- Scouts and Brownies were not invited. Organisers realised that they had not invited voluntary organisations.
- Studley has been identified as area with health and inequality deprivation.
- Pilot study to amalgamate all agencies together.
- Poor perception of young people and anti social behaviour.
- Studley has not received any money for initiatives.
- Focus of attention is young people aged 13-23 years. Need to get young people together to instigate next step.

Cllr Mrs Wade made the point that it would be hard to get people involved due to the loss of the Fire Station and problems with the library. If, for a third time, no one listens people will be turned off totally. At present there is no funding only for a Consultant. Very cynical that nothing will come out of this; there will be another report and then it will all go away. Proof of the pudding is who is invited to the meeting, no one who can make any difference.
