- Studley Fire Station will close by the beginning of October 2012
- Awaiting a response from portfolio holder on the position of the Studley Young Firefighters following closure of Fire Station
- The old Library has now been purchased but the name of the purchaser has not been released however Cllr Rickhards is confident that usage of adjacent quadrangle will continue to be maintained by Studley in Bloom.
- Cllr Rickhards and Sue Werner developing use of Community Library by local schools and young people

- Studley Youth Club – Rob McCluskey has produced a feasibility study to enable Youth Centre to be used as multi-agency resource, targeted at young people experiencing difficulties. Anna Stowe will attend a Parish Council meeting on a date to be fixed to discuss the various activities and the ‘governance’ of the new venture.
- Cllr Rickhards to question Portfolio holder as to why County Council has not signed up to the Action Plan on sexual exploitation of young people as suggested by Barnardo’s
- Studley Car Boot Sale - the parking restrictions have not been implemented and Cllr Rickhards is chasing this up

Cllr Holder had heard that Young Firefighter would be closing on 21 Sept 2012 and asked Cllr Rickhards to check.

Cllr Holder reported that an appeal on a licensing issue had been lodged by Johnsons Coaches.
