ROAD TRAFFIC REGULATION ACT 1984

THE WARWICKSHIRE COUNTY COUNCIL (DISTRICT OF STRATFORD ON AVON) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS, ON STREET PARKING PLACES AND RESIDENTS' PARKING) (CONSOLIDATION) (VARIATION NO. 24) ORDER 2015

Warwickshire County Council propose to make an Order under the Road Traffic Regulation Act 1984, the effect of which will be to vary the existing District of Stratford on Avon (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) Order 2008, as briefly described (by approximate measurements) in the Schedule below.

Exceptions to waiting restrictions described in the Schedule below will permit waiting for the purposes of picking up and setting down passengers, loading and unloading goods, for vehicles displaying a disabled person's badge and in connection with the maintenance of the road and the supply of gas, water or electricity.

A copy of the proposed Order, together with a copy of the Order to be varied, plans showing the lengths of road affected and a statement of the Council's reasons for proposing to make the Order may be inspected at the Warwickshire County Council Main Reception, Shire Hall, Market Place, Warwick; at Stratford on Avon District Council, Elizabeth House, Church Street, Stratford on Avon; Studley Community Library, Studley Village Hall High Street Studley and at the Public Library at Henley Street, Stratford on Avon during normal opening hours.

SCHEDULE

Studley.

Kiln Close.

No Waiting Sun 8am-12pm between 01 Apr and 31 Oct.

Both side of the Cul de sac section from a point 7 metres east of junction with Kiln Close for remaining length.

West side from the junction with Brickyard Lane south for 15 metres.

Brickyard Lane.

No Waiting Sun 8am-12pm between 01 Apr and 31 Oct.

Both sides of the Cul de sac section 25 metres east of the junction with Brickyard Lane east for its remaining length.

West side from the junction with Kiln Close north for 64 metres.

Station Road.

No Waiting Sun 8am-12pm between 01 Apr and 31 Oct.

North side 36 metres east of The Slough east for 108 metres.
