#### **ROAD TRAFFIC REGULATION ACT 1984**

# THE WARWICKSHIRE COUNTY COUNCIL (DISTRICT OF STRATFORD ON AVON)(CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS, ON STREET PARKING PLACES AND RESIDENTS PARKING) (CONSOLIDATION) (VARIATION No 26) ORDER 2016.

Warwickshire County Council propose to make an Order under the Road Traffic Regulation Act 1984, the effect of which will be to vary the existing District of Stratford on Avon (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) Order 2008, as briefly described (by approximate measurements) in the Schedule below.

Exceptions to waiting restrictions described in the Schedule below will permit waiting for the purposes of picking up and setting down passengers, for vehicles displaying a disabled person's badge and in connection with the maintenance of the road and the supply of gas, water or electricity.

Exceptions to any waiting restrictions for loading and unloading goods apply to all roads listed in the areas of Stratford- upon- Avon, Shipston on Stour and Wellesbourne. The exceptions also apply to Alcester Road (Studley) and New Road (Studley). For the avoidance of doubt High Street (Studley) will not be subject to the exclusion.

A copy of the proposed Order, together with a copy of the Order to be varied, plans showing the lengths of road affected and a statement of the Council's reasons for proposing to make the Order may be inspected at the Warwickshire County Council Main Reception, Shire Hall, Market Place, Warwick; at Stratford on Avon District Council, Elizabeth House, Church Street, Stratford on Avon; Public Library at Henley Street, Stratford on Avon, Studley Community Library, Studley Village Hall, High Street, Studley and at the Community Library, 12 Church Street, Shipston on Stour, during normal opening hours.
