#### Bypass update

Warwickshire County Council has reluctantly withdrawn its Legal Challenge at the High Court on the Government's decision not to build a bypass.

The sole ground of the challenge was that the Government had, in breach of its own declared policies, rejected the bypass scheme without carrying out an appraisal. The High Court hearing was scheduled for late November.

At the Public Inquiry in January 2004 the Government accepted that no such assessment had been carried out therefore the County Council began High Court proceedings. However, in May this year the Government revealed an assessment had indeed been carried out in May 2003.

Although the assessment was superficial and its findings not disclosed at the Public Inquiry in 2004, it is extraordinary that the Government failed to discover an appraisal had been carried out in 2003 and only did so after it had become a key issue at the Public Inquiry and subsequent High Court proceedings.

At the Cabinet meeting on the 6th October the decision was taken on the advice of the County's legal team to formally withdraw the challenge as it now would be impossible to succeed.

This is a very disappointing outcome. However, when the section of the A435 is detrunked from Gorcott Hill to Alcester and the responsibility for the road passes to Warwickshire County Council, we can actively start lobbying for traffic calming measures to encourage motorists to find alternative routes.

### **CHRISTMAS LIGHTS APPEAL**

#### **PLANNING**

The Planning and Compulsory Purchase Act 2004 has come into force on 15th September 2005. Stratford District Council has to produce a Local Planning Framework (LDF) to take the place of the District Local Plan Review after 2007.

It includes social and economic issues as considerations in planning decisions. It should be shorter, flexible and quickly updated and involve the community from the start.

It has to conform to the Regional Spatial Strategy (West Midlands) as the County Council Structure Plan will eventually be scrapped.

A Government Planning Inspector will vet it and make recommendations for changes which will be mandatory, not optional on the District Council.

In other words the Framework must follow the Regional Strategy.

#### **VISA SCAM**

Computer users are warned to beware of a new scam email that is circulating. The email purports to come from VISA and asks recipients to click on a link to 'update their account information'. The email goes on to say that failure to do so will lead to the suspension of the Visa Card.

**BEWARE.** this is a 'phishing' scam the email does not come from Visa but from fraudsters who wish to trick you into disclosing personal and financial information and PIN's. If you receive this email delete it immediately—**DO NOT** reply or click on any links
