7. Co-op Site – Cllr Mrs S Redman

Proposed Cllrs Mrs S Redman, seconded Mrs J Beard, voting unanimous to write to Cllr Darren Pemberton, Mr Tony Perks and leader of Stratford District Council to for an update on the site. SDC promise of the compulsory purchase of the site has not happened.

- Proposed: 2 nos: free standing signs at the entrance to the site to replace existing and bring hotel over to new brand.

- 18/02209/FUL: Mr Rameez, Abdul & Ali Raja, Wahab & Meer Dantree Enterprise, Garage Blocks, The Grove, Studley, B80 7QL
- Proposed: Demolition of garage court and erection of 2 nos dwellings.
- Revised plan- the 2 properties have been re-oriented 180 degrees to in an effort to reduce concerns on overlooking. Plot 2 is also now partially set back from the Plot 1.
- The proposed ridge height of the properties has been reduced. In addition obscure glazing has been introduced on the proposed south facing side elevation, whilst the previously proposed skylights in the north facing roof space have been removed.
- A parking court has now been proposed and the vehicular access to the properties altered.

- **Over Development of the site**
- **Concern regarding vehicle access/egress from site for both plots and also feel visibility to access no: 47 are restricted and unsafe.**
- **Restricted access to rear of No: 9, layout of parking arrangements will cause conflict for residents at No: 47 & No: 9 in The Grove.**
- **Still contrived development which is a 4 bedroom property with only 2 parking spaces- insufficient for accommodation that is proposed and tandem parking as proposed will cause difficulty.**
